PROJECT PROFILE: G7 SUMMIT WASTE SERVICES

*Liquid & General Waste Management
Support for 7 Canadian Armed Forces
Facilities*



PROJECT DESCRIPTION

CORE was contracted to support the liquid waste and general waste disposal for the Canadian Armed Forces (CAF) which included 7 sites in total.



SCOPE OF WORK

The objective of this work was to supply containers that exceeded government expectations for safety and spill containment, with 24/7 on-call services to remove full containers and supply additional bins as required.

Waste Characterization and Treatment Strategy

- Waste was predetermined by container type. Hazardous waste, primarily aviation fuel, was removed by a third-party supplier and transported to approved disposal facilities.
- Treatment Priority: CAF and client, SCA Inland Americas (SCA), required extensive documentation of all disposals to ensure proper handling and compliance with environmental regulations.
- Disposal Pathway: Non-hazardous waste, including grey water and general bin waste, was sent to non-hazardous disposal facilities, while hazardous waste was properly managed and disposed of by the third-party supplier.

CORE Oversight and Compliance

- CORE oversaw all aspects of waste management to ensure full compliance with transportation and regulatory requirements.
- Logistics Management: Coordinated all pickups within a 12-hour window using government-approved, badged personnel.
- Disposal Coordination: Managed third-party hazardous waste transport to ensure safe and compliant disposal.
- Outcome: Sites were serviced as requested, sometimes with less than 24 hours' notice. All waste was properly handled and disposed of.

PROJECT HIGHLIGHTS

High regulatory requirements including achieving full government approved clearance for all site access permits; Services supplied on a 24/7 basis in a high demand environment under heavy scrutiny.



SPECIFIC SERVICES

- Supplied new spill kits for airfield locations.
- Managed a third-party agreement to provide 1,000L containers meeting or exceeding fuel-waste regulations.
- Coordinated short-term general waste pickups for five temporary CAF camps, ensuring operations were completed within a 12-hour window.
- Provided overall project management, acting as an intermediary between CAF, SCA, and third-party suppliers.



PROJECT OUTCOME

The project was completed on schedule. CORE adapted to several scope changes during the contract, including providing additional bins, increased pickups, and extra equipment as required. SCA was very satisfied with CORE's ability to maintain smooth operations while accommodating these changes and has since engaged CORE for further work.
